MOBILE MAINTENANCE SUPERVISOR

Under the direction of the Mobile Maintenance General Foreman, the Mobile Maintenance Supervisor is responsible for organizing all mechanical planned and unplanned repairs to the equipment. To supervise the routine and emergency repairs and major component change outs of all mobile mining equipment. To supervise, coordinate, lead and monitor all activities with the highest standard of safety across the mine-site. This position will be based at the Eagle Gold Mine-site working on a rotational basis with 12-hour shifts. Responsibilities are noted below which will include but are not limited to:

Main Tasks and Responsibilities:

- Ensure employees are in compliance with all Company policies/procedures and safety regulations;
- Zero environmental non-compliances, accidents and incidents;
- Provide leadership to the mobile maintenance team;
- Conduct daily tool box meetings;
- Supervise, coordinate and monitor routine maintenance of mobile mining equipment;
- Coordinate activities for the mobile maintenance crews, providing training as needed;
- Coordinate the availability of parts for maintenance projects;
- Identify and balance resource demands for work group and approve timecards;
- Communicate performance expectations to crew members and address any performance issues that can be improved;
- Perform shop inspections at the beginning of each shift; and
- Organize work assignments with on-shift supervisors.
