LONG TERM MAINTENANCE PLANNER

Under the direction of the Maintenance Manager, the Long Term Maintenance Planner is responsible for the planning and scheduling of maintenance of the mobile and stationary assets at the Eagle Gold Mine. This position reports to the Senior Reliability/Planning Engineer and works closely with Superintendents and Supervisors across all areas. This position will work on a rotational basis with a 12-hour shift. Responsibilities are noted below which will include but are not limited to:

Main Tasks and Responsibilities:

- Perform duties safely, and in compliance with VGC, Territorial and Federal safety guidelines and procedures
- Zero environmental non-compliances, accidents and incidents
- Accurately scope and plan shutdown work for the Fixed Equipment Assets
- Accurately scope and plan jobs for the Mobile Fleet including major mobile equipment rebuilds
- Accurately plan long term Project work
- Coordinate/schedule Maintenance Contractor support and site Maintenance teams
- Develop Gantt charts and update work plans, equipment Bill of Materials, work orders and preventive maintenance procedures and schedules in CMMS
- Scheduling available manpower, ordering and tracking parts, and documenting work tasks. This includes developing and maintaining the maintenance management system in CMMS program (work order creating and tracking, preventive maintenance strategies, managing the functional location structure, etc.)
- Coordinate maintenance with other departments and operations including tracking schedule compliance, reviewing completed work and prioritizing work to be completed
- Behave in a way that demonstrates support of Victoria Gold’s Vision and Values
