Loss Prevention Officer

Under the direction of the Health, Safety & Manager, the Loss Prevention Officer is responsible for carrying out and supporting a wide range of health, safety and security activities, while working on both day and night shifts on a rotating basis (2x2). This position at times may be physically and mentally demanding and requires critical thinking and sound judgement. The ideal candidate will possess a great work ethic with a drive for improvement. Responsibilities are noted below which will include but are not limited to:

Main Tasks and Responsibilities:

- Be a courageous safety leader, adhere to and support safety, security and environmental rules and procedures
- Respond in times of emergencies and participate in Mine Rescue (ERT) activities and training
- Maintain advanced first aid certification and provide first aid service in support of medics
- Provide overall site protection and support as needed, which includes but is not limited to security, fire suppression systems and tools.
- Support implementation of High Potential Risk Control and Occupational Health and Hygiene strategies.
- Promote Health and Safety leadership among employees and contractors, providing guidance and direction on the application of site procedures and programs
- Perform workplace monitoring and control access and egress to site.
- Assist with Blast clearing/guarding as required
- Provide support to safety incident investigations and health and safety programs, including confined space, hazardous energy isolation and fall protection
- Perform periodic health and safety inspections and participate in audits as required
- Capable of working with minimal supervision
